## What you need to know about Family Life Education (FLE)

Concerned parents of [www.parentandchild.org](http://www.parentandchild.org) are hard at work again this year ensuring that Fairfax county parents get the facts about the latest Family Life Education curriculum. As in years past, they have reviewed each lesson and devised a simple chart to help parents identify which lessons deserve a closer look.

### Examples:

#### 1 Grade 7

Throughout the FLE curriculum, the physical reality of biological sex has been replaced by “*sex assigned at birth.*” Students are taught that ideas about “*gender identity*” are more significant than biological sex.

#### 2 Grade 9

Ninth graders are advised: “*Before choosing to be sexually active you should carefully consider what you are really comfortable doing.*” This lesson is entitled “*Abstinence*”.

#### 3 Grade 10


Tenth grade lesson on the “*elements of healthy dating relationships*” includes instruction on “*affirmative consent*” to sexual activity.
